#### 3. Objective

Team Rynkeby is a European charity project that raises money every year for children with critical illnesses in Denmark, Sweden, Finland, Norway, the Faeroe Islands, Iceland, Germany and Switzerland. The charity work concludes with a cycling trip to Paris in July, and in September, all the funds raised are presented to the organisations that Team Rynkeby Fonden partners with.

All participants in Team Rynkeby cover their own expenses for a bike, bike clothing and hotel costs (but may have team sponsors to cover for fuel for cars, ferry costs and training weekends etc.).

Almost half of the costs of running Team Rynkeby are covered through a fixed annual amount from the Eckes-Granini Group, a smaller part is covered by commercial partners, while the rest of the costs are covered via the collected funds. From season 23/24 the contribution to cover administrative costs will be deducted before the funds are handed over to the charities. The objective is to keep the percentage used of the collected funds low, and it must never exceed 12%.

The funds raised are donated to the organisation that Team Rynkeby Fonden works with, in the country, in which this Agreement is concluded.

## 4. Rights and Responsibilities Between the Parties

The sponsor must pay the amount that appears in the section 'The agreed sponsorship'. The sponsorship must be paid in accordance with the payment terms set out in the invoice sent under separate cover.

It is the Sponsor's responsibility to provide the materials that will enable Team Rynkeby Fonden to meet its commitments in respect of 'visibility'. Team Rynkeby Fonden is entitled to determine the placement and size of the Sponsor's logo — unless specifically stipulated in this Agreement.

Team Rynkeby Fonden grants the Sponsor the right to use Team Rynkeby's name, logo, banners and graphic elements in the Sponsor's own marketing as per the guidelines under the 'Visibility' section. All materials can be downloaded from Team Rynkeby's website.

Team Rynkeby Fonden stores personal data in accordance with applicable rules and regulations in order to fulfill our obligations towards our sponsors. When you accept our sponsorship agreement, you give at the same time your consent that Team Rynkeby Foundation can pass on your personal data to the local Team Rynkeby Steering Committee and selected participants to ensure that they can contact you later regarding a possible continuation of the sponsorship next year.

Especially in case of, but not limited to events of force majeure, including epidemic and pandemic outbreaks, which shall include but not be limited to COVID-19 outbreak, Team Rynkeby may not in the sole opinion of Team Rynkeby be able to organize the intended races. If these situations, Team Rynkeby will strive to organize at least one national race for each Team Rynkeby team if considered safe by Team Rynkeby. Under no circumstances whatsoever and howsoever shall Team Rynkeby in such situations be liable to the Sponsor, for any kind of losses, delays, liabilities, claims, non-performance or other effects of whatsoever kind being a direct or indirect result of such changes in or cancellations of the intended race program and the Sponsor further accepts that the Sponsor will not ask for, and cannot be, in any way reimbursed for their sponsoring amount due to any cancellations of or changes in the intended ride program.

The sponsorship amount must be specified in DKK, SEK, NOK, EUR, ISK or CHF excluding VAT

## 7. The Period of Validity

Once the signed Sponsorship Agreement has been set up in Team Rynkeby Fonden's system, it will be forwarded electronically to the Sponsor for approval. The Agreement is put into effect once the Agreement has been approved electronically. Team Rynkeby will send an invoice to the Sponsor once the Agreement has been approved electronically. If it is a platinum or gold sponsorship agreement, this Agreement must be approved electronically no later than 13/01/2026 (Platinum) if spots for logos is guaranteed. Platinum and gold sponsors accepted after this deadline are not guaranteed the wanted location of the logos. All sponsorship agreements expire on 31/08/2026.

This Agreement may be terminated with immediate effect in the event of a substantial breach of contract by either party. Significant delay in the payment of the sponsorship amount or the provision of other services, as well as acts by or the behaviour of either party which, objectively, are contrary to generally accepted good practice or the law, or otherwise cause harm to the other party's reputation, are always considered as a substantial breach. Any dispute regarding or in any way related to the sponsorship contract, including disputes regarding the existence or validity of the sponsorship contract, is subject to Danish law and the Court of Svendborg, Denmark, shall have exclusive jurisdiction as the first instance.

Upon termination/expiry of the Agreement, the parties remove the other party's name, logo and other symbols possibly allowed from their material and website, as well as from other such publications and contexts in which the other party's name, logo or other symbols are used.
